Moreover, it delivers an additional productivity advantage during assembly, and being tougher and stronger than most traditional materials, it resists breakage during fitting and assembly.

The combination of break resistance, optical clarity and design flexibility has persuaded many manufacturers to replace traditional acrylic materials with Lexan Margard FMR5 XT sheet in windshield applications.

In Italy, Honda specified the material some years ago for their motor scooters.

The advantages of Lexan Margard FMR5 XT sheet are leading to its adoption for the emerging generation of high-performance scooters. These large 500cc scooters place even higher demands on materials that match safety requirements and aerodynamic design capabilities.
