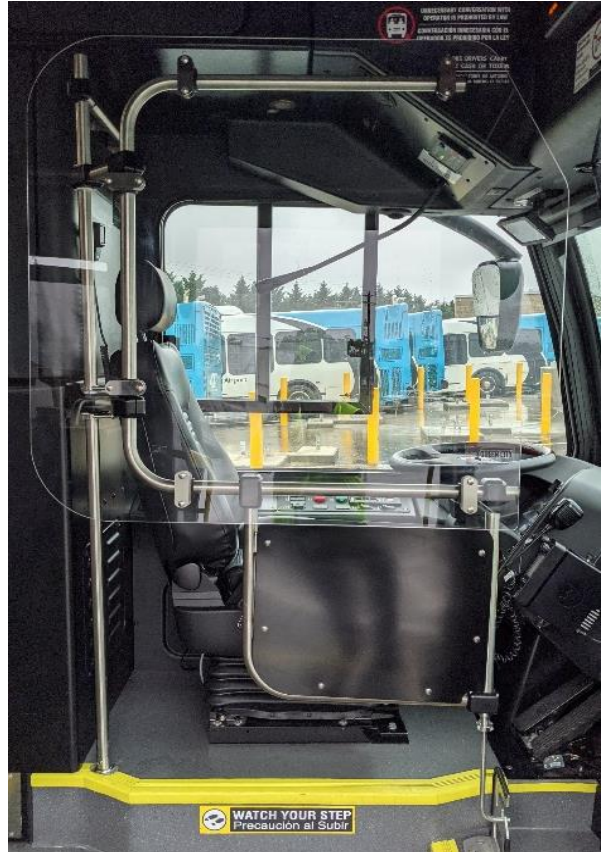
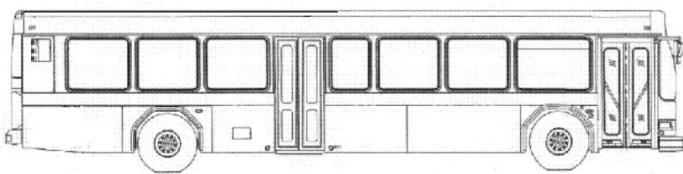
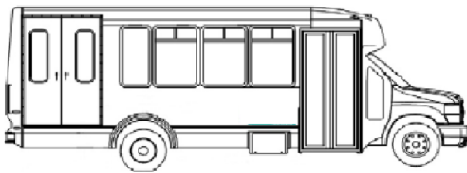
CHEMICAL RESISTANCE AND CLEANING

FLAME RETARDANCY

LEXAN™ MARGARD™ MR10 polycarbonate sheets are tested according to the major global bus standards (meeting FMVSS 302* norm) and are also approved for use in other means of public transport like Taxi, Trains and Motor coaches. As a thermoplastic, LEXAN™ sheet will partly melt under the intense heat of a fire, however, in terms of its own flammability, it will not contribute to the growth of a fire through flame spread.
