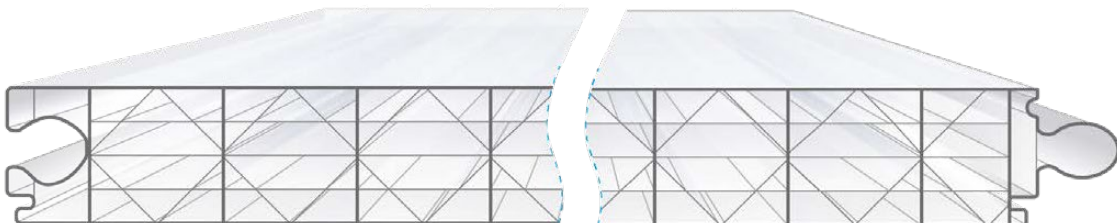
## JET BASE FAÇADE RENEWAL
