The City of Edmonton wanted to energize new life in an aging grandstand within a suburban park which is both modern and inspiring into a cohesive open landscape.

The design uses the sloped seating of the bleachers as the inspiration for the building form and experience. The structure's shape resembles an open, engaged body posture. The building itself appears to be leaning in, to watch the events on the sports field below.


