## LIVE MAS: TACO BELL'S NEW STORE ROLL-OUT FEATURES MODERN FAÇADE

The first Taco Bell in New Zealand opened its stores in 2019, in West Auckland. Gaining quick popularity, Taco Bell expanded to roll out its iconic meals across the rest of the country over the past years. Nowadays, Taco Bell has 14 franchise companies from Auckland to Wellington in the North Island, and from Christchurch to Dunedin in the South Island.

When it came to designing the iconic brand's storefronts, wall cladding was used to create a neon, back-lit effect of the logo. It became a way to highlight the brand colors as a powerful identifier for a strong impact, and as a feature cladding for the public frontage of the buildings. Using the bright, almost neon purple of Taco Bell as a backlight makes this façade stand out at any time of day, making it a warm welcome and signaling to the emblematic brand as just within reach.
